Additionally we currently have nearly 20 reps working on behalf of the sector across a range of health programme boards, steering groups and task and finish groups bringing the perspective of communities to strategic conversations. Watch this space for updates from our reps.

## What is the Alliance?

The Sussex VCSE Leaders Alliance is an informal collaboration of leaders from the breadth of Sussex coming together to work on behalf of the wider voluntary, community and social enterprise sector. It's made up of 20 plus senior CEOs from a range of health and care disciplines, as well as those working across the wider determinants of health, for example, homelessness, housing and advice services. Our ambition is to work strategically with health and care partners to tackle health inequalities and improve population health for the people of Sussex. The Alliance is funded through NHS Sussex. ## **Commissioning Framework**

One of our most significant pieces of work is the development of a framework that will help shape the way VCSE services are commissioned by the NHS and local authorities in a way that improves health outcomes and reduces inequalities for the population of Sussex. Commissioning is the process of analysing needs, planning, purchasing and monitoring health services from the VCSE.

The work is overseen by a multi-agency oversight group representing local authorities, NHS and the VCSE. The group last met on the 13th September.

A second face to face Commissioning Framework workshop, with leaders and commissioners from the VCSE and Sussex ICS (local authorities and the NHS), will be held on the 18th October, following one on 18th July.

A VCSE Task & Finish Group have been providing input into the framework development. During September and October, we will engage with the wider VCSE sector to develop the framework further. <u>Get the latest updates</u> and find out more on on the VCSE Intranet.

#### **Shared Delivery Boards**

Following recent recruitment, the VCSE will be represented on 6 NHS Sussex Shared Delivery Boards: Inequalities, Social Care and Discharge, Integrated Community Teams, People and Development, Mental Health, Learning Disabilities and Autism and Primary Care. Our vision is to embed the VCSE as a strategic partner within the integrated care system. Our VCSE board members will bring a wealth of sector knowledge and expertise to strategic planning, decision making and the delivery of health and care services across Sussex. To do so, they will ensure connectivity with each other across each of the boards, with colleagues across our sector and within the multi-layers of the health and care system.

Shared Delivery Boards include integrated care partners (NHS, Local Authorities, VCSE, and NHS providers) who oversee the delivery of the priorities in the <u>Shared</u> <u>Delivery Plan</u>. The Delivery Plan sets out how the priorities of the <u>Improving Lives Together</u> strategy will be achieved.

### **CREATING CHANGE** Why I became a VCSE rep

As a Sussex VCSE Leaders Alliance representative Sue Livett makes a positive impact within system leadership, changing mindsets and building relationships between the VCSE and health and care sectors. The Aldingbourne Trust Chief Executive talks about her role and why she wants to represent the people of Sussex.



'I became a VCSE representative because I think it is important for the VCSE to be present where policies, objectives and networks are being developed. I specifically volunteered to sit on the NHS Sussex People Committee (now the

People and Development Shared Delivery Board) because, as a Chief Executive, workforce issues are a top priority. I sit on various other boards and I'm part of various networks across Sussex. I have been actively trying to influence decision makers for years.

'As part of system leadership advocating for the VCSE, I see how the system is being designed, where I can bring up issues of concern and add value. It is a strength of the VCSE in Sussex that the sector itself is coming together and reps are feeding in and looping information back to help us understand and interact with a complex system.

The VCSE Lead and I have done a lot of work in raising the profile and understanding of the VCSE. We also welcomed the opportunity to input into the <u>Sussex Health and Care Working with People and Communities Strategy</u>. Since then, I've canvassed the views of the VCSE to ask what priorities/opportunities for collaboration would be useful. This has enabled us to have some tangible 'asks' as the ICS develops. I've been welcomed by several new NHS colleagues and can see there is a real will to try to do things differently and recognition that the VCSE will have a role in this.

'I'm actively advocating for the sector: identifying areas of collaboration within the ICS; encouraging more integration and skill sharing across systems; linking VCSE to networks and initiatives and reinforcing the value of the VCSE and the role we play in health and social care. These small wins all lead to bigger gains and as a result of this work we are now having conversations that have a huge impact on the health and care system.'
